Mayor Cal Lathan called the meeting to order at 7:00 pm.

M/2/C (B. Leader, C. Genthner) to approve the payment of claims # 12 to # 17 in the amount of \$ 13,460.80. Passed 4 – 0. Claim # 12 to Barry J. Carestio was made for survey work done at the Field Parking Lot.

Tax Assessor – Lisa Bennett - regarding Section 520 NYS Real Property Tax Law
Lisa Bennett discussed with the Village Board revenue that could be returned to the Village when a property is transferred to a new owner and previous tax exemptions have been removed. In the past, the Village has not recovered this tax for the year that the property transferred ownership. Lisa shared with the Village Board all of the qualifying factors for a homeowner to receive an exemption. Since The Village of Livonia collects taxes at a different time from the Town and County, the Village would need to calculate the Exemption Amount on their own. There is a computer program to help with this. Grievance time would be the same as The Town of Livonia. The Village Board will consider passing a Resolution to establish a date that this new process could begin. Mayor Lathan will discuss this with Attorney Skivington.


Dear Mr. Lathan and Village Board,
