DISCUSS CLEAN RECYCLING

Supervisor Gott welcomed Don Wester, Conesus Town Supervisor and Conesus Councilmember Dick Corrigan. They discussed whether to financially support the C.L.E.A.N. recycling center again. The historic disagreement between management has since been quelled, and the two towns are proposing to work together to enhance the facility. Repairs that need to be done include deteriorating walls, excavation and estimates on the most fiscally responsible replacement plans. Livonia residents do not pay more than Conesus residents to use the facility. Supervisor Gott suggested the town of Livonia make a financial contribution to the C.L.E.A.N. recycling project. Supervisor Wester thanked the town board for listening and considering. They are in the process of putting the financial need together currently. Councilmember Breu asked about prices raising for non-Conesus residents, Supervisor Wester stated that was not discussed at Conesus town board meetings.
